- 5. This Revised Proxy Form must be signed by you or your attorney duly authorised in writing or, in the case of a corporation, must be executed either under its common seal or under the hand of an officer or attorney or other person duly authorised to sign the same.
- 6. In the case of joint holders of any share, any one of such joint holders may vote at the Meeting, either in person or by proxy, in respect of such share as if he were solely entitled thereto. However, if more than one of such joint holders be present at the Meeting and who tenders a vote, whether in person or by proxy, the vote of the joint holder whose name stands first in the register of members of the Company will be accepted to the exclusion of the votes of the other joint holder(s).
- 7. To be valid, the Revised Proxy Form together with the power of attorney or other authority (if any) under which it is signed, or a certified copy thereof, must be lodged at the Company's place of business in Hong Kong at 34/F, Shui On Centre, 6-8 Harbour Road, Wan Chai, Hong Kong not less than 48 hours before the time fixed for holding the Meeting or any adjournment thereof (as the case may be).
- 8. The proxy need not be a member of the Company but must attend the Meeting in person to represent you.
- 9. Completion and return of the Revised Proxy Form will not preclude you from attending and voting at the Meeting if you so wish. In such event, the instrument appointing a proxy shall be deemed to be revoked.
