Means of Receipt and Language Election for Corporate Communication

Pursuant to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited, we are writing to seek your election in relation to the following matters regarding the corporate communication (“Corporate Communication”) of Shui On Land Limited (the “Company”) to be dispatched in the future.

Corporate Communication means any document to be issued by the Company for your information or action, including but not limited to:

- (a) annual report;
- (b) interim report;
- (c) notice of meeting;
- (d) listing document; and
- (e) circular.

You may choose:

- (1) to read the Corporate Communication published on the Company’s website (“Website Version”) instead of receiving printed copies; or
- (2) to receive a printed English version of the Corporate Communication only; or
- (3) to receive a printed Chinese version of the Corporate Communication only; or
- (4) to receive both the printed English and Chinese versions of the Corporate Communication.

For the purpose of environmental protection and cost saving, we recommend you to select the Website Version. Even if you have chosen the Website Version, you have the right at any time by sending reasonable prior notice in writing to the Company's Branch Share Registrar or by email to "sol.ecom@shuion.com.cn" to change your choice.

Please cross the appropriate box in the enclosed Reply Form and sign and return the same with the envelope provided to the Company's Branch Share Registrar, Computershare Hong Kong Investor Services Limited, at Rooms 1806-07, 18th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong.

If the Company do not receive the Reply Form from you by 28 May 2009 and until you inform the Company's Branch Share Registrar by reasonable prior notice in writing or notify the Company by email, only a printed Chinese version of the Company's Corporate Communication will be sent if you are a shareholder who is a natural person with a common Chinese name and has an address in Hong Kong appearing on the register of members of the Company. Otherwise, we will only send you a printed English version of the Company's Corporate Communication.

Please note that: (a) both the printed English and Chinese versions of the Corporate Communication will be available from the Company or its Branch Share Registrar on request; and (b) both the English and Chinese versions of the Corporate Communication will be available on the Company's website at www.shuionland.com and the website of The Stock Exchange of Hong Kong Limited.
