# Shui On Land's Foshan Lingnan Tiandi clinches prestigious international architectural accolades

[Foshan, 19 February 2009] The Master Plan of Foshan Lingnan Tiandi developed by Shui On Land Limited (Shui On Land) has recently won several major international architectural laurels. They include the American Institute of Architects (AIA) Honour Award for Regional & Urban Design 2009, the profession's highest recognition of works that exemplify excellence in architecture and urban design. Among six projects receiving this celebrated award, the Master Plan of Foshan Lingnan Tiandi is highly praised by the jury panel for its balanced and viable scheme conserving and restoring the vibrancy of the historical old town, improving the quality of the urban environment, and creating a safe and sustainable central district. The project has also received Commended Award in the MIPIM Architectural Review Future Project Awards 2009 in the category of Regeneration and Master Planning, and Merit Award for Urban Design 2008 from the AIA Hong Kong Chapter. These awards are further testimonies to Shui On Land's strength in innovative community master planning.

Recipients of the world-class AIA Honour Award for Regional & Urban Design were all US projects until this year. The Master Plan of Foshan Lingnan Tiandi received Merit Award from the AIA Hong Kong Chapter last year and was recommended to AIA's US headquarters for the Honour Award. Selected from more than 3,000 submissions from around the world, Foshan Lingnan Tiandi is one of only two China projects to receive this prestigious award this year.

Foshan Lingnan Tiandi is situated in the prime location of Zumiao Donghua Lane of Chancheng District in Foshan, one of the best-preserved and largest old towns in China and the world. The project is an urban redevelopment project with emphasis on conserving Foshan's old town and its Lingnan style architecture while simultaneously employing modern architectural concepts, creating a modern central district that preserves local cultural characteristics. The project incorporates traditional arts and craftsmanship to conserve Lingnan style architecture. A group of traditional architecture with Guo-er shaped gables, which best represents Lingnan-style architecture, will be restored. The project will also preserve 22 historic sites, including Jian's Mansion, Marriage House and Confucius Temple, Lizhongsheng Ancestral Shop, sustaining high social and cultural value.

In line with Foshan's economic development, Foshan Lingnan Tiandi redevelopment project will inject new life to this historic city and will strive to become a new landmark in Foshan and Southern China, attracting fame from the world.
